

Tattoo Release Form

Design

I understand Studio Muscat will not copy artwork of other artists or studios, and will modify designs as necessary.

I understand there may be additional design fees if I request changes after the design is started.

Regarding the Tattoo

I understand I must be careful of the following to ensure a smooth session and better healing process:

- Avoid sunburn where the tattoo will be
 - Moisturize and take care of my skin from a few days before the session
 - Avoid exercise that may cause muscle soreness where the tattoo will be

I understand I must refrain from entering hot springs, pools, onsens, rivers etc for a month after the tattoo to avoid the risk of infection and damage to the tattoo.

I allow my tattoo to be photographed and published on social media, websites, and magazines.

※Please inform the studio if you would not like your photograph published.

I understand variations in color and design may exist between the tattoo art and the actual tattoo applied to my body.

※Patch tests are available to test for allergic reactions to ink.

Cancellation Policy

I understand I can reschedule my booking with 15 or more days notice without losing my deposit, subject to artist availability. (Please note artists can be booked several weeks in advance)

I understand I will lose my deposit in the following scenarios:

- If I do not contact or arrive at the studio 30 minutes after the scheduled time
 - If the tattoo cannot be administered due to severe sunburn, injury, or other skin irregularities
 - If I reschedule within 14 days of the booking for any reason, including but not limited to COVID, personal/work emergencies, travel restrictions, etc.

I understand my full deposit will be settled as a cancellation fee if I cancel my booking, or do not contact or visit the studio before the expiration date.

Deposit

I understand my deposit will be applied to my final tattoo session.

I understand my deposit will be valid for 1 year after payment or my last visit.

I understand Studio Muscat will not refund my deposit under any circumstances, unless the artist or studio requires a cancellation. I understand the studio will make no exceptions to this policy for any reason.

In Addition:

I understand I cannot have laser hair removal administered over my tattoo.

I understand I may be denied MRI scans or certain life insurance plans because of my tattoos.

I freely accept and expressly assume any and all risks that may arise from tattooing.

I hereby release Studio Muscat, their artists, and employees of all legal responsibility for my tattoo.

The following statements must all apply:

I am over 20 years of age.

***Please bring photo ID with your DOB (e.g. Driver's license, passport)**

I am not pregnant or nursing.

I do not have Herpes or Eczema on the location of my tattoo.

I do not have Diabetes, Epilepsy, a heart condition, or any other condition which will affect my tattoo session.

I do not have Hepatitis B, Hepatitis C, HIV/AIDS or any other blood transmissible infections or diseases.

I am not under the influence of alcohol or drugs.

I agree to all of the above statements, and consent to the application of the tattoo. This release form covers all my bookings at Studio Muscat.
